


With reference to above subject reference no. 3 the letter of block education officer rural div. vijayapur has permitted rupa international English medium school solapur bypass road Vijayapur (un-aided) dist. Vijayapur has sanctioned affiliation to start 9th for the year 2016 17 and 2017 18 10th standard as per reference number 2 letter of additional commissioner public education dept. Dharwad . As per reference number 3 the block education officer rural division Vijayapur has recommended rupa international English medium school solapur bypass road vijayapur(un-aided) dist. Vijayapur they have to start 9th standard for the year 2016 17 and 10th standard for the year 2017 18 . the affiliation is un aided one subject to the following conditions first affiliation is granted.

Condition

1. Govt. order no. ED709PGC2017 Bengaluru dated: 7.3.2018 as per this order the school administration has deposited DD no. 370032 dated: 30.10.2018 for sum of rupees ten thousand only. The challan copy is valid for future ten years

2. As per rule the school has to maintain minimum admissions and attendance.

3. As per Karnataka education act 36 -39 all primary and secondary schools obtain affiliation from 1.6.1995.
4. As per Karnataka education institution (Recognition of primary and secondary school) Rules 1999 dated 04.11.1999 affiliation rule no. 4, all the schools have to provide all civil amenities and complete the below mentioned conditions.
 1. Karnataka education Institution (classification , registration and specification circular etc. rules 1995 and time to time passed ordered rules and regulations to be followed
 2. As per 1995 rule 4,5,6 & 8 explained well built building ,good and satisfactory surrounding ,drinking water ,separate toilets for boys and girls to be provided and other facilities be provided
 3. Library ,Books, scientific instruments ,sports amenities, maps, charts and other all equipments are in good quantity .
 - 4.To appoint employees as per state government directions which is issued time to time
 5. Karnataka education institutions (Classification & registration) Rule 1997 .As per rule 4 good economic condition and submit all relevant documents .
 6. As per rule 18,19,20 of 1995 , textbooks teaching methods, examination methods, working days, working hours, housekeeping works time, the details compulsory followed
 7. Students admission condition and rules, fees must be compulsory followed
 8. To whom the school is granted they have to run the school in same place in same name and in same meaning in same survey number in any condition the placed survey number should not be changed.
 9. As per rule and act all necessary documents and registers should be maintained
 10. In junior primary school 40, higher primary school 100 and in secondary school least 25 students must be present.
 11. The school premises is kept open for exams, census and all trainings.

12. In accordance with the dept. and Govt. the fixed books and type of exam teaching should be done.
13. To follow the Govt. and dept. instructions and orders issued time to time.
5. Respective education institute should not open additional divisions without prior permissions of Govt.
6. Before starting of school the institute must deposit a security deposit in the name of Dist. Asst. Dir. and secretary of the institute jointly.
7. Every year medical examinations of students should be done in accordance with the rules.
8. The building of the school should be with all security measures like fire, cyclone, electric short circuit and other incidents and building should be in accordance with national build code of India 2005.
9. School building should be equipped with fire extinguishers and all the teachers and staff should be trained in handling these equipments.
10. Karnataka education institutes(un-aided primary,secondary schools and PU educational society employees service rules and condition) rules 2005 and Govt. order number ED104SEP2005 dated : 12.01.2006 and amendments made time to time and orders in accordance with these school teachers provided with service safety and service book maintaining. Atleast pay headmaster 22800, co teacher – 17650, 2nd div. clerck – 11600 and group D servant- 9600. Payment should be made through bank. A statement should be submitted to the block education officer in respect of service benefits ,same should be examined by the block education officer(this rule is not applicable to aided schools)
11. Govt. notification number ED/75/PMC95 dated 7.9.1998 and dated 29.12.1998 these refers to aided schools only (not applicable to aided school).
12. In accordance with Govt. order number ED104SEP2005 dated 12.01.2006 the educational qualification of the teachers and other post should be equal to the Govt. school and training should be compulsory and in accordance with the rules the eligible candidates only be appointed

13. The administration of this institute must have 5 lakh rupees cash deposit or immovable property worth the same.

14. Every Educational institute audit their books of accounts every year by a CA and gets a certificate.

15. Karnataka Educational institutes (division control) and syllabus rules 1995 provide all facilities.

16. If the school maintain a vehicle specify the information in accordance with the law in proper form.

17. The documents and representation produced at the time of affiliation should be true. At any time if it is found to be untrue affiliation should be cancelled.

18. The block Education Officer satisfies himself with regards to affiliated schools complying with all rules and regulations.

19. The block education officer shall take necessary steps against the institute which have not followed the Karnataka educational act 1983 shiksana 39(1)(A).

20. The administration of the school and the staff has to follow all the conditions and aide code rules chapter 3 rule 9 provide all basic amenities after verifying all these the block education officer has put forth renewal of affiliation for the 9th and 10th standard should be submitted.
